No. MDF-0615/C.R.34/Ind-9.- In exercise of the powers conferred by sub-section (1) of section 9B of the Mines and Minerals (Development and Regulation) Act, 1957 (67 of 1957), in its application to the State of Maharashtra, the Government of Maharashtra, hereby establishes a Trust, as a non-profit body, to be called the District Mineral Foundation Trust, for each revenue District (except Greater Mumbai District which doesn't have mining areas) in the State of Maharashtra with the Governing Council, the Managing Committee

1. The Governing Council shall consist of the following Members :-

- 1 District Guardian Minister ... *Ex-Officio* Chairman;
- 2 Three Members each from amongst the ... Members;
Members of Maharashtra Legislative Assembly
and Members of Maharashtra Legislative
Council in the District (Preferably from the
mine affected areas) to be recommended by the
Guardian Minister concerned and nominated
by State Government.
- 3 Collector of the concerned District ... Member- Secretary;
- 4 Not more than three representatives from ... Members;
amongst the mineral concession holders in the
District to be recommended by the Guardian
Minister concerned and nominated by State
Government.
5. Two representatives of the NGO's (Non- ... Members;
Government Organizations) in the District to be
recommended by Guardian Minister and
nominated by the State Government
6. Chief Executive Officer, *Zilla Parishad*(if the ... *Ex-Officio* Member;
mine affected areas are in municipal
corporation or municipal council limits then an
officer of the municipal corporation or
municipal committee shall also be ex officio
member,
- 7 District Mining Officer ... *Ex-Officio* Member;
- 8 District Vocational Training Officer ... *Ex-Officio* Member;
- 9 District Tribal Welfare Officer ... *Ex-Officio* Member;


